

## **Jam Connect – Terms of Use & Safety Disclaimer**

### **1. Acceptance of Terms**

By accessing or using the Jam Connect platform, website, mobile application, or related services (“Jam Connect,” “Platform,” “Service”), you agree to be legally bound by these Terms of Use. If you do not agree to these Terms, you may not use the Service.

Jam Connect is not responsible for the misuse, unauthorized sharing, disclosure, or exploitation of any information voluntarily shared by users.
